

Report of Scrutinizer

I, Jyoti Soni, of Jyoti Soni & Associates, Practising Company Secretaries (Membership No. ACS 38058), having my office at P.no.3, Keshav Marg, Shivaji Chowk, Brahampuri, Jaipur 302002 Rajasthan have been appointed as the Scrutinizer to conduct the Postal ballot process for seeking the approval of members by way of Special resolution:

1. Re-appointment and Payment of Remuneration to Shri Sachin Ranka as Chairman & Managing Director of the Company.

pursuant to the Postal Ballot Notice dated March 30, 2022, issued under Section 110 and other applicable provisions of the Companies Act, 2013 ("the Act") read with the Companies (Management and Administration) Rules, 2014, as amended from time to time read with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17 /2020 dated April 13, 2020, General Circular No.22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021 and General Circular No. 20/2021 dated December 8, 2021 issued by the Ministry of Corporate Affairs (hereinafter collectively referred to as "MCA Circulars").

The Postal Ballot Notice dated March 30, 2022 along with statement setting out material facts under Section 102 of the Act as confirmed by the Company were sent through electronic mode only to those Members whose e-mail addresses were registered with the Company / Depositories.

The Company had engaged the services of Central Depository Services (India) Limited ("CDSL") to provide remote e-voting facility to its Members. The shareholders of the Company holding shares as on the" cut-off" date of Friday, April 8, 2022 were entitled to vote on the resolutions as contained in the Notice.

The remote e-voting period commenced from Monday, April 18, 2022 at 09:00 a.m. (1ST) and ended on Tuesday, May 17, 2022 at 05:00 p.m. (1ST) and the CDSL e-voting module was disabled thereafter. The votes cast under remote e-voting facility were thereafter unblocked and were counted. I have scrutinized and reviewed the votes cast through remote e-voting based on the data downloaded from the CDSL e-voting system and have maintained a register in which necessary entries have been made in accordance with the Companies (Management and Administration) Rules, 2014, as amended. The Management of the



Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, rules and the MCA Circulars relating to remote e-voting on the Resolutions contained in the notice of Postal Ballot. My responsibility as scrutinizer for the remote e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the said resolution.
